I further agree that if you, your affiliates, your and their respective officers, employees, representatives, successors, and assigns produce or distribute a project based upon the same general idea, theme or situation and/or have the same setting or background and/or taking place in the same geographical area or period of history as the said project material, then unless you have substantially copied the expression and development of such idea, theme or situation, including the characters and story line thereof, as herewith or hereafter submitted to you by me in writing, you shall have no obligation or liability to me of any kind or character by reason of the production or distribution of such project(s), nor shall you be obligated to compensate me in connection therewith. I agree that nothing in this agreement, nor the submission of the project material, shall be deemed to place you in any different position from any other member of the public with respect to the project material. Accordingly, any part of the project material that could be freely used by any member of the public may be used by you without liability to me.

I further understand and agree that you are not responsible for the return of any material submitted, and I acknowledge that I have retained a duplicate copy of such material in my possession. In addition, I understand that any fee submitted in conjunction with said material will be donated to the CAPE FOUNDATION in order to offset costs incurred with the organization of the CAPE FOUNDATION 2009 NEW WRITER AWARD, and will not be returned if material is not selected.
